INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (as it may be amended, restated, supplemented or otherwise modified from time to time, this **Agreement**) is entered into as of October 11, 2022 between HRA Group Holdings Ltd., Crossworks Manufacturing Ltd., Wallace Holdings Ltd., 536331 B.C. Ltd., H.R.A.U.S.A. Ltd., WorldWide Diamond Trademarks Ltd., and Dialog Solutions Inc. (the Grantors) and Royal Bank of Canada, as lender (the Lender).

WITNESSETH:

 - all present and future right, title, and interest in and to the following: (a) all trademarks (including service marks), trade names, trade dress, and trade styles and the registrations and applications for registration thereof and the goodwill of the business symbolized by the foregoing; (b) all licenses of the foregoing, whether as licensee or licensor; (c) all renewals of the foregoing; (d) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof; (e) all rights to sue for past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing; and (f) all rights corresponding to any of the foregoing throughout the world, including, but not limited to, the trademark and service mark registrations, applications. and licenses set forth in Schedule B hereto, as Schedule B may be supplemented from time to time by supplements to this Agreement which may be executed and delivered by the Grantors to the Lender from time to time (the Trademarks); and
 - right, title, and interest in and to the following: (a) all copyrights, rights and interests in copyrights, works protectable by copyright, copyright registrations, and copyright applications: (b) all re-

newals of any of the foregoing; (c) all income, royalties, damages, and payments now or hereafter due and/or payable under any of the foregoing, including, without limitation, damages or payments for past or future infringements for any of the foregoing; (d) the right to sue for past, present, and future infringements of any of the foregoing; and (e) all rights corresponding to any of the foregoing throughout the world, including, without limitation, the registrations and applications and copyright licenses set forth in <u>Schedule C</u> hereto, as <u>Schedule C</u> may be supplemented from time to time by supplements to this Agreement which may be executed and delivered by the Grantors to the Lender from time to time (the **Copyrights**).
