

## Description

This circular is a reissue of circular S.EA.577 to include additional ratios. The secondary winding is in two sections, each section of which is connected to a separate terminal block.

By means of the terminal blocks, the secondary winding sections may be connected in series for the high ratio and in parallel for the low ratio.

For the high ratio, either one of the links is closed and the other open, the leads being connected to the terminals with the open links.

For the low ratio, both of the links are open and short leads are used to join both pairs of terminals in parallel observing the correct polarities and the external leads are connected to the most convenient pair.

A schematic diagram of the connections is shown on the nameplate.

With the high ratio connection, both links must be closed in order to short-circuit the secondary winding.
