APPROVAL LISTING

WAYNE BLEND-O-MATIC GASOLINE DISPENSER

Under the provisions of the Weights and Measures Act, Chapter 292, R.S.C. 1952, and Regulations thereunder (P.C. 6894), the apparatus specified and illustrated herein has been listed as an approved device and may be used in Canada in accordance with the conditions applicable.

Apparatus Listed: Blend-O-Matic computing gasoline dispenser Model 511-D manufactured by the Wayne Pump Company, 829 Richmond Street, West, Toronto, Ontario.

Rating of Apparatus: Maximum capacity 12 G.P.M.

Application: Retail gasoline trade.

Conditions: As prescribed in P.C. 6894.

Description: This device is a gasoline dispenser designed to dispense gasoline #200 (regular gasoline) #280 (100% octane concentrate) or any one of up to seven blends of the primary liquids.

The dispenser is equipped with two separate inlets (one from the #200 gasoline storage tank and one from the #280 storage tank).

These inlets lead to two separate pumps and meters. When delivering a blend the volume flow from each meter is controlled by the position of the blend selector indicator to provide the proportions of the primary liquids required.

The blend selector operates the customer price indication and cannot be changed when the dispenser is operating.

The blending is controlled by a series of gears and spindles which opens or closes the blending valves in proportion to the blend selected. The registrations of the meters are integrated and appear as one delivered quantity and one money value on the sale indicator panel. The discharge hose is composed of a hose within a hose. The inner hose carries the octane concentrate and the outer hose the #200 gasoline. The two liquids are blended in the single discharge nozzle.

The dispenser is provided with a single sight glass for each discharge line and is equipped with two rotating discs which rotate in proportion to the amount of each of the basic liquids used in the blend dispensed.
