GILBARCO - GASOLINE DISPENSERS WITH KEY CONTROLLED SUBSIDIARY CUSTOMERS' TOTALIZERS AND TOP MOUNTED TICKET PRINTERS

The gasoline dispensers listed on S-WA. 591 may have key-controlled subsidiary totalizers installed, provided that the individual totalizer in use is visible so that its advance can be checked against the verified and sealed meter; as required by W & W Circular 69/l, Sections 2.1 and 2.2. At the present time the totalizers will be supplied without the shutters, so that all totalizers are exposed at all times. Typical model numbers for these dispensers are as follows:

- 625-150-710 Dispenser with 12 gpm capacity, suction pump, visigauge (code 7), 10 subsidiary totalizers.
- 625-250-716 Dispenser with 18 gpm capacity, suction pump, 16 subsidiary totalizers.
- 625-350-720 Dispenser with 18 gpm capacity, remote pump, 20 subsidiary totalizers.

The change of 100 to 150, etc., designates the Keytrol assembly.

- 701 to -720 denotes dispensers with 1 to 20 keys.
- 721 to -740 denotes dispensers with 1 to 20 keys and a filter before the meter.

These dispensers may also be equipped with top mounted zero-start or accumulative ticket printers; the 5th digit changes to a 3 for a zero start printer and to a 4 for an accumulative printer. These printers are not interlocked to prevent the printing of incorrect or fraudulent tickets and the printer shall be labelled: "Printed Ticket Not Legal for Billing" in accordance with W & M Circular 71/1.

Typical model numbers are as follows:

- 625-130-710 Dispenser with zero start printer and 10 subsidiary totalizers.
- 625-240-716 Dispenser with accumulative printer and 16 subsidiary totalizers.
