Approved: CIASSIC PUMP MANUFACTURERS LIMITED - REGISTERS FOR CASOLINE DISPENSERS manufactured by: Kienzle Apparate, GmbH, Villingen, Germany.

Apparatus Listed: Price computing type registers for gasoline dispensers, model numbers as follows:

| lodel Number | Description |
|-------------------------------|--|
| M'26/220/3 /36/64-2222 | Four wheels on gallonage and four wheels on money register; gallons wheel graduated to tenths and hundredths. |
| A 326/220/3/36/64-2222 | Same as model AP26 above, except equipped with key-control panel for 36 to 72 keys, and corresponding number of individual totalizers. |
| APD26/220/3/36/64-2222 | Same as model AP26 above, except equipped with an interlocked side-mounted receipt printer; receipt shows the quantity of fuel delivered and the computed value of the sale. |

Rating: Maximum operating rate 20 gpm or \$20.00 per minute.

Application: These registers are intended and approved for use on gasoline dispensers used in retail trade. They may be installed on Classic or other makes of dispensers.

Description: On these registers, price changes are made by control knobs, and can be adjusted up to 99.9 cents per gallon. Total money register capacity is \$99.99. When the price at which the computer is set is adjusted, the indicated per gallon price is automatically adjusted the same amount.

Description (cont'd):

An automatic reset to zero mechanism is provided; in turning the operating handle to the "off" position before returning the nozzle to the boot, the reset spring is loaded. When the operating lever is turned to the "on" position, the spring resets the registers, and only after the registers are reset is the motor switch closed.

The key-controlled subsidiary register system is interlocked so that only one key can be turned at a time, and so that the pump must be shut off before the key can be removed.

The receipt printer is supplied by a roll of paper as in a cash register. There is no number printed to indicate the number of the transaction, only the quantity and the computed price are printed. The printer is interlocked so that only the quantity delivered (with corresponding money value) can be printed and vice versa and only 1 such receipt can be printed.

Testing: Dispensers using these registers will be tested in the standard usual manner.
