<u>DEVICES LISTED:</u> Computing type gasoline dispensers for use with self-serve postpay systems, model numbers as listed below:

The models listed are lighted; the corresponding unlighted models are also approved for use with the Transac Systems.

In the foregoing model numbers, the sixth position from the left is used to indicate a dispenser modified for use with a Transac system. Thus, model number C164-111-702 becomes as follows:

C164-1F1-702 - with Money Pulser only C164-1G1-702 - with Volume Pulser Only C164-1L1-702 - with Money and Volume Pulser

APPLICATION:

Retail gasoline trade, self-serve installations.

<u>DESCRIPTION</u>: The dispensers listed above are known as the "Trimline Series". The only difference between these models and those originally approved is the addition of an electric reset and pulser or pulsers to transmit money and/or volume values to the console in the cashier's booth.

NOTE: Transac systems currently being produced no longer use the "call" switch supplied on the original version, and a standard electric reset is used. Therefore, in the Trimline series above, "4" remains as the seventh digit of the model numbers.

In the D and G series, "2" remains as the sixth digit of the model numbers.

Previously "5" was used in the sixth place of all model numbers to indicate a special electric reset with call switch.

A Transac II system is now available for use with as many as 12 dispensers.

MARKING: All dispensers incorporating the Transac postpay system shall have installed on each dial face a permanent legent "in case of disagreement between this register and the cashier's register this register shall be taken as correct" in letters at least 3/16" high.

TESTING: The standard tests for a gasoline dispenser shall apply. There is no need to seal the readout on the cashier's console, as legally the register on the dispenser is the basis for the sale.
